A. <u>Sales To-date</u>. C. Hanson reported that sales at currently at \$18,740 with 1,118 tickets sold through 133 purchases. These sales have all been through online sales.

Hanson noted that we have received the 4,000 printed tickets and they will be distributed at all social functions, can be mailed to Members on their request, and may be picked up at the office; dedicated days/times have been scheduled to make ticket pickups more efficient.

- a.) <u>Membership Survey Results & AZ SB1377</u>. The Board reviewed the results of the Membership survey on social events and SB1377 on COVID liability protection for Arizona nonprofits, which was recently signed into law.
- b.) <u>May Steak Fry & Attendance Criteria</u>. K. Bedient discussed plans for the Steak Fry on May 21 at Tanque Verde Guest Ranch, including:
 - We will be in the Cottonwood Grove area and the event will be all-inclusive and Members will not be asked to work.
 - We will have a surf & turf menu, a band, and dancing.
 - The Evite will include Tanque Verde Guest Ranch's COVID requirements, and we will ensure all participants adhere to them.
