3. President's Report

T. Miller discussed the postponement of our 2020 Event and related items; further discussion was held under the new business agenda item.

4. Old Business

No old business was discussed.

5. Centurion Foundation Report

No report.

6. Executive Director's Report

C. Hanson reported on ongoing efforts to related to postponing our 2020 Event, including contacting vendors to cancel services, cancel contracts, and request refunds on deposits; continually updating the

website with developing information; fielding questions from sponsors and ticket purchasers; contacting our current charities; assisting Event venue chairmen; seeking funding opportunities; and other related efforts.

7. New Business

The Board discussed the postponement of our 2020 Event and related issues; key discussion points included:

- A. With the 2020 being canceled, all tickets and passes that contain the 2020 date will be reprinted.
- B. Members will be asked to request their sponsors and ticket customers to convert their purchases to a tax-deductible donation, otherwise we will automatically roll over their purchases to 2021, unless they request a refund. C. Hanson will draft and distribute a public announcement on our plans for rescheduling the 2020 Event and talking points and draft letter for Members to use with sponsors and ticket customers.
- C. The Board discussed the need to consider conducting smaller and more frequent fundraising events to counter the risks of relying only on one major fundraising event a year and agreed to explore various options.
- D. The Board and guests discussed the 2020 raffles and whether to continue to hold the raffles in 2020 as planned, or postpone to 2021 along with the Event. There was unanimous agreement to also postpone the Super Raffle and Regular raffles to 2021 along with the Event.
- E. The Board discussed the \$50,000 received from the TMC Foundation for its Premier Sponsorship for the 2020 Event and agreed to ask the Foundation its preference for carrying it over to 2021 or receiving a donation from The Centurions for 2020 at a similar dollar amount.

MOTION to postpone the Super Raffle and Regular Raffle to 2021, ceasing sales in 2020 due to the current COVID-19 shutdowns. Motion seconded and APPROVED.

MOTION to ask TMC Foundation if they would prefer to carry over its Premier Sponsorship payment to 2021, or to receive a donation from The Centurions for 2020 at a similar level. Motion seconded and APPROVED.

8. Action Items

- A. C. Hanson will draft and distribute a public announcement on our plans for rescheduling the 2020 Event and talking points and draft letter for Members to use in requesting sponsors and ticket holders to convert their purchases to a donation, otherwise we will roll over to 2021, unless they request a refund.
- B. K. Bedient will contact Arizona Fireworks Productions to request that our deposit be refunded.
- C. C. Hanson will coordinate with Bryan Hannley and Deron Davenport to contact Van Means to call off his raffle prize donations for the 2020 Event.
- D. C. Hanson will continue working on Event postponement related efforts, including working with vendors to cancel contracts and seek deposit refunds; ensure Members, customers and the public are kept informed of developments; assisting venue chairmen; providing website updates; and developing Member and public communications.

9. Adjournment

With there being no further business, the meeting was adjourned at 6:25 PM.

Event Board Members,

Below is a ballot to approve applying for funding under the CARES Act. Since this funding would come in the form of a loan as opposed to a grant or other means of funding, it will require Board approval.

While we expect to use the bulk of the funding under the loan forgiveness provisions, it does carry potential for a portion to carry interest at a maximum of 4% payable over 10 years:

<u>MOTION</u> to approve applying for a loan under the federal CARES Act through Commerce Bank of Arizona to the level allowable under the Act, any portion of which not used for the approved purposes (i.e., rent, utilities, and payroll) within eight weeks of loan origination by lender may incur interest at four percent over 10 years.
