Membership Invoices: Please Note 'New' Process!

To ensure an effective invoicing and collection system, we're going back to strictly adhering to the process specified in our Bylaws for The New Centurions (Section 2.6):

- 30 days ALL financial obligations are due in full within 30 days of the invoice; this includes ALL <u>dues</u>, <u>event fees</u>, and <u>Event ticket & sponsorship sales revenue</u>.
- 60 days ALL members with an invoice 60 days past due will be <u>ineligible to attend ANY</u> <u>social event</u>; e.g., Membership meetings, social events, Dinner Dance, etc.
- 90 days If a member's invoice reaches 90 days past due their <u>membership will be</u> <u>automatically terminated</u>.

Please keep in mind that this process is automatic, as required by our Bylaws.
