## **Reminder: 'New' Invoicing Process!**

To ensure an effective invoicing and collection system, we're going back to strictly adhering to the process specified in our Bylaws for The New Centurions (Section 2.6):

- 30 days ALL financial obligations are due in full within 30 days of the invoice; this includes ALL <u>dues, event fees</u>, and <u>Event ticket & sponsorship sales revenue</u>.
- 60 days ALL members with an invoice 60 days past due will be <u>ineligible to attend ANY</u> <u>social event</u>; e.g., Membership meetings, social events, Dinner Dance, etc.
- 90 days If a member's invoice reaches 90 days past due their <u>membership will be</u> <u>automatically terminated</u>.

Please keep in mind that this process is automatic, as required by our Bylaws.
