Bylaws Provisions for Late Payments

To ensure an effective invoicing and collection system, the Board is now strictly adhering to the process specified in our Bylaws for The New Centurions (Section 2.6).

Please keep in mind that this process is automatic, as required by our Bylaws:

- ALL invoices are due in 1-30 days ALL financial obligations are due in full within 30 days of the invoice; this includes ALL <u>dues</u>, <u>event fees</u>, and <u>Event ticket & sponsorship</u> <u>sales revenue</u>.
- 60 days past due ALL members with an invoice 60 days past due will be <u>ineligible to</u> <u>attend ANY social event</u>; e.g., Membership meetings, social events, Dinner Dance, etc.
- 90 days past due If a member's invoice reaches 90 days past due their <u>membership</u> will be automatically terminated.

Also please note that we are exploring a new online invoicing system through QuickBooks.
