drop off all donated prizes at TMC's at the location of our old office at 5301 E. Grant Road (NE corner Grant & Beverly).

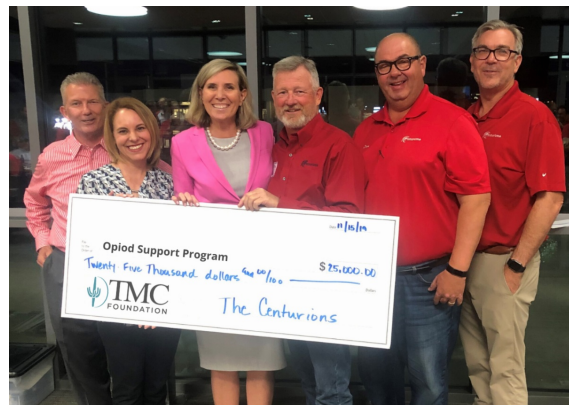

Centurion Foundation News

The Centurion Foundation was granted \$25,000 in matching funds for use in TMC's Opioid Awareness and Prevention Program.

This partnership allows for the Centurion Foundation to work with TMC to address the escalating opioid epidemic. This is directly aligned with the Foundation's mission to support our community's youth.

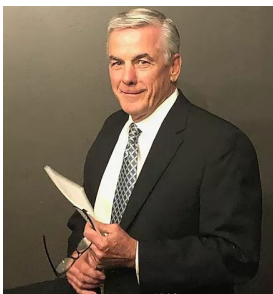
Since Arizona began collecting data on opioid deaths in 2017, at least two people per day, on average, have died of an opioid overdose in our state.



TMC's opioid program includes:

- Investing in funding a medical director position;
- Changing prescribing practices and use of opioids throughout the hospital;
- Implementing stricter security protocols and are requesting that inpatients identified by staff as opioid-dependent sign a care contract;
- Building a separate unit to care for babies exposed to opioids;
- Developing community programs to support a continuum of care through innovative partnerships with like-minded providers.

Mark Diebolt, Active Member of The New Centurions, is running for County Attorney. The seat is open for the first time in over 20 years with the retirement of longtime incumbent Barbara LaWall.

Reminder: Automatic Bylaws Provisions for Late Payments

- **ALL invoices are due in 1-30 days.** ALL financial obligations are due in full within 30 days of the invoice; this includes ALL dues, event fees, and Event ticket & sponsorship sales revenue.
- **60 days past due - Membership Suspended.** ALL members with an invoice 60 days past due will be ineligible to attend ANY social event; e.g., Membership meetings, social events, Dinner Dance, etc.
- **90 days past due - Membership Terminated.** If a member's invoice reaches 90 days past due their membership will be automatically terminated.

All payments may now be made online through the link in each invoice you receive.
